3. Continuously analyze and improve practices and processes to reduce the risk and adverse impact on plant and work safety and Health of our stake holders and communicate the annual environment, health and safety performance of SCIPL in the Annual report.
4. Systematically identify hazards and manage them with appropriate risk assessment techniques like Safety Inspection, Job safety Analysis, Process Hazard Analysis (PHA), Hazard Identification & Risk Assessment (HIRA), Environmental Aspect & Impact, Health Check-up Etc. and subsequent remedial measures.
11. Ensure HAZOP studies are carried out not only for new projects but also for plant changes and modifications.
12. Consider the compliance to health and safety requirements while evaluating the individual performance,
