Labour Laws

- **Child labour**

- **Remuneration**

- **Working conditions**

- Bribery (commercial or otherwise) is not at all acceptable & it is against the core value of SCIPL. Supplier must not engage into any such activities. This includes 'NO GIFT' policy .
- Supplier, if believe that employee of SCIPL is engaged into illegal business practise, then they should immediately report it to SCIPL by email or call.
- Suppliers are expected to comply with all other laws & regulations applicable to their products & services, customers, business community & public, etc.
- Mechanism to report any malpractice shall be in place such as Whistle blower Policy and Procedure.
